Outline of the Course

1. Course description, goals, objectives, and learning outcomes

The discipline "Social Economy" is focused on the acquisition of future economists' professional knowledge, skills and competencies through the prism of measuring the value of human life, personal development in the process of their lives and social capital to ensure socio-economic progress, balancing the proportions of modern economy.

In the process of studying the discipline the need for mutual complementarity of mechanisms of market self-regulation, state regulation, the activities of civil society and business in the structure of the mechanism of social coordination to overcome deep socio-economic imbalances of modern economic systems.

Historically formed models of the social economy are considered and compared to identify patterns of further development of national and global economic systems. In addition, there are significant relationships between social, environmental and economic aspects of modern regulatory mechanisms of the economy.

Particular emphasis is placed on the need to increase the level of transparency (inclusiveness) of institutional support of the modern social economy.

Based on the assimilation of educational material and its practical analysis, students are invited to identify conditions, features and trends in the social economy in Ukraine, to offer their vision of the necessary changes in the structure of regulatory mechanisms.

According to the curriculum of student training by the Faculty of Management and Marketing discipline "Social Economy" belongs to the cycle of general training disciplines in specialty 051 "Economy" and promotes not only economic knowledge and skills. but also provides future professionals with skills that contribute to the effective implementation of their professional qualities in enterprises and organizations of various forms of ownership, considering the need to balance social and economic interests of stakeholders.

The subject of the discipline is the laws and patterns of evolution of economic systems through the prism of achieving conditions of social harmony and compromise between individual stakeholders, socio-economic groups, society as a whole and the state in the relationship of economic and social relations, combining sustainable, inclusive development people.

The purpose of the discipline is the formation of students' professional competencies:

- ability to develop a set of recommendations for overcoming social imbalances in the modern economy; to the development of social responsibility programs and planning the creation of social enterprises for the formation of social incentives in the process of implementing the mechanism of social coordination;
- ability to monitor and evaluate the effects of the implementation of social measures by the state, business, civil society institutions.

As a result of mastering the discipline, students will acquire the following skills (program learning outcomes):

- demonstrate the ability to act socially responsibly and consciously on the basis of ethical principles, to value and respect cultural diversity, individual differences;
- Analyze the effects of the implementation of social measures by the state, business, civil society institutions; identify opportunities for the realization of human personality in the process of socio-economic activities; evaluate and analyze the effectiveness of social responsibility, social entrepreneurship and state social policy as components of the mechanism of social coordination.

The discipline is studied for 1 semester.

6. Self-study

There are no topics that are submitted for full self-study for full-time study. Part-time study involves mastering some of the topics of the course yourself. VTS on the topics of the discipline involves mastering the issues of lectures and preparation for practical work, writing an essay, preparation for the MCR and exam.

According to the structure of the discipline, a module test is provided for students of all forms of education. The purpose of the test is to test the theoretical knowledge and practical skills acquired by students on the basics of social economy.

1 academic hour is allotted to full-time students for modular control work. It is held in practical classes for full-time education. An average of 2-4 academic hours is allotted for preparation for the MCR.

According to the curriculum in the study of the discipline "Social Economy" provides for the implementation of an individual task in the form of an abstract. The abstract is performed by students according to the agreed and approved schedule.

The aim of the essay on "Social Economy" is to develop students' ability to evaluate and critically analyze the effectiveness of market self-regulation, social responsibility, social entrepreneurship, public social policy and other components of social coordination, as well as consolidate knowledge on key issues of social economy. The abstract is based on fundamental and professional-practical knowledge and is the basis for the formation of knowledge in the main sections of the discipline "Social Economy".

It is mandatory for students to adhere to the approximate schedule of the abstract, as shown in Table 1.1, as this provides an opportunity to timely identify and eliminate deficiencies and errors in its content and design.

While working on the essay, students have the opportunity to consult with the teacher, submit for approval or review of individual components of the work. The main ways of communication between the student and the teacher can be personal counseling (at a specified and agreed time according to the teacher's schedule), e-mail,

Google Docs & Drave Google, Trello, Telegram, Zoom, Skype, CAMPUS, classroom.google and other means of communication.

Conditions for successful writing and delivery of essays, requirements for it are given in "Social Economy: essay [Electronic resource]: textbook. way. for students. full-time and part-time forms of education of the first bachelor's level of higher education in specialty 051 "Economics" educational and professional program "Economics of Business Enterprise" / KPI. During the semester, students are given time to work independently to master the topics of the discipline. In independent work they focus on the topics for the exam, topics of lectures and practical classes, as well as a range of questions recommended by the teacher to perform cases, business games, situational exercises and more.

Attendance Policy and Assessment

7. Attendance policy

Attending classes

Attendance at lectures, practical classes, as well as absence from them, is not evaluated. However, students are encouraged to attend classes, as they teach educational (theoretical and practical) material and develop skills defined by the purpose of the discipline. The assessment system is focused on obtaining points for student activity, as well as performing tasks that can develop practical skills. Failure to perform the tasks defined by the discipline entails the impossibility of successful passing the test.

Control measures missed

Thematic task, as well as abstract (essay), modular test, which is submitted for verification in violation of the deadline, are evaluated taking into account the penalty points.

Policy of deadlines and rearrangements

The student has the right to complete all simplified types of thematic tasks and other forms of activities defined by this syllabus no later than 3 days before the intermediate certification, ie the period in which they were to be credited. Tasks submitted for testing in violation of this rule are evaluated in "0" points.

Features of the organization of work with students studying for a double degree or for certain other reasons are not able to attend classes (full-time / distance)

Students studying for an exchange, a double degree program or due to illness, etc., but unable to attend classes must notify the teacher within the first two weeks of the semester. Such students will work according to an individual schedule agreed with the teacher. The schedule must be agreed with the dean's office of the faculty. Control measures (intermediate and semester) are also taken according to the agreed individual schedule.

Procedure for appealing the results of evaluation measures

Students have the opportunity to raise any issue related to the control procedure and expect it to be addressed in accordance with predefined procedures.

Students have the right to challenge the results of control measures, but it is necessary to argue, explaining which criterion they do not agree with according to the evaluation letter and / or comments.

Calendar control

Intermediate attestation of students (hereinafter - attestation) is a calendar boundary control. The purpose of the certification is to improve the quality of student learning and monitor the implementation of the schedule of the educational process by students.

The policy and principles of academic integrity are defined in section 3 of the Code of Honour of the National Technical University of Ukraine "Igor Sikorsky Kyiv Polytechnic Institute" (https://kpi.ua/code).

The norms of ethical behaviour of students and employees are defined in section 2 of the Code of Honour of the National Technical University of Ukraine "Igor Sikorsky Kyiv Polytechnic Institute" (https://kpi.ua/code).

8. Monitoring and grading policy

Student rating (during the semester) consists of points that the student receives for:

- work on practical classes (17 classes);

- performance of modular control work (1 academic hour is performed).
- performance and discussion in a practical lesson of an individual task (abstract).

Scoring criteria.

Work on practical classes - 2 points. (17 * 2 = 34 points):

- quality performance of tasks without errors, active participation in cases, problem solving and answering questions (not less than 90%) 2 points;
- high-quality performance of the proposed tasks, but with minor shortcomings (not less than 75%) 1.5 points;
 - participation in the performance of tasks, but making mistakes (not less than 60%) -1 point;
- making significant mistakes, failure to complete tasks or absence from class (work does not meet the requirements of "sufficient" and performed less than 60% or not performed at all) 0 points.

Execution of modular control work - 6 points.

- the work is done and comprehensively, unmistakably and in a logical sequence revealed the order of execution 6 points;
 - unmistakably, the content of the work is fully disclosed 5-4 points;
 - performed the work, but revealed only the main aspects of the problem 3 points;
 - no significant elements of the work were revealed, the tasks were partially completed 2 points;
 - tasks performed less than 50% 1 point;
 - no answers 0 points.

The result of the control measure for a student who did not show up for it is evaluated with zero point.

Execution of an individual task (abstract) - 20 points:

- the work was done and comprehensively, unmistakably and in a logical sequence revealed the order of execution 20-18 points;
 - unmistakably, the content of the work is fully disclosed 17-15 points;
 - performed the work and revealed the main aspects of the problem 14-12 points;
 - no significant elements of the work were revealed, the tasks were performed superficially 11-8 points;
 - tasks are completed by less than 50%, no answers 7 0 points.

The result of the control event for a student who did not show up for it is evaluated with a "0" point.

For each week of delay with the delivery of tasks submitted for practical classes within the first and second attestations (each block of tasks is submitted before the attestation), a penalty of -1 point is awarded for the examination.

For participation in the conference, writing publications in scientific journals, participation in competitions and other types of additional activities (including courses) related to the subject area of the discipline, the student can receive from 2 to 10 incentive points (the number of points increases when writing creative tasks yourself or taking certified courses).

Abstracts: 2 points.

Article: 5 points.

Some topics of courses, short-term trainings, etc.: 2 points.

Course with a certificate and / or participation in student competitions of scientific works, competitions related to the subject field of the discipline: 10 points.

Calendar control: conducted twice a semester as a monitoring of the current state of compliance with the requirements of the syllabus.

Semester control: exam.

Conditions of admission to the semester control:

The condition for a positive first certification is to obtain at least 14 points, the second certification - to obtain at least 30 points.

The amount of rating points obtained by the student during the semester, subject to enrollment in the abstract and MCR, is transferred to the final grade in accordance with the final table of correspondence of rating points to grades on the university scale. The total number of points for the semester is (RC) 60. Another 40 (RE) points students have the opportunity to score on the exam.

Thus, the rating scale of the discipline is R = RC + RE = 100 points.

The exam is in writing. During the exam, the teacher has the right, if necessary, to ask the student additional questions orally.

The examination test consists of 2 questions from the list provided in the appendix to the work program and the test.

Each theoretical question is evaluated with 15 points according to the following criteria:

- "excellent" a complete answer (at least 90% of the required information), provided appropriate justification and personal opinion 15 13 points;
- "Good" a fairly complete answer (at least 75% of the required information), performed in accordance with the requirements for the level of "skills", or minor inaccuracies) 12... 9 points;
- "Satisfactory" incomplete answer (not less than 60% of the required information, performed in accordance with the requirements for the "stereotypical" level and some errors) 8... 5 points;
- "unsatisfactory" unsatisfactory answer 0 points.

The test consists of 5 closed questions and is evaluated in 10 points, where the weight of each question is 2 points. Completely correct answer is evaluated in 2 points, partially correct in the range of the selected evaluation scale. Wrong answer - 0 points.

The sum of the starting points and the points for exam will give you the final grade:
